

Lockport Township Fire Protection District Will County, IL Board of Trustees Meeting

Minutes of the Regular Meeting February 27, 2019

The Regular Meeting of the Lockport Township Fire Protection District was held on Wednesday, February 27, 2019, at Lockport Township Fire Protection District Station #6, 19623 Renwick Road, Lockport, Illinois.

Board President Dave Palya called the meeting to order at 6:00 P.M. and asked that everyone stand for the Flag Salute and a moment of silence in honor of the past and present members of the Lockport Township Fire Protection District, and those serving in the U.S. Military Service.

CONSENT AGENDA 19-09

Trustee Palya asked that Items 1) through 4) on the Consent Agenda are considered to be routine in nature and will be enacted upon in one motion.

Trustee Paul Siegel requested that the Regular Meeting Minutes January 23, 2019 to be removed.

Trustee Siegel explained that his recollection of the motion on Action Item 19-07 Collective Bargaining Agreement was different than what is written. After talking with Attorney Ottosen I realized that the action was not made by me but verbalized by Karl and the motion was made by me. Again his reclamation was not that Karl had already sent the suggested changes to the Union but that it was going to be done after Trustees had a chance for discussion on the changes. There was a lot of communications that the rest of the Board did not get throughout this whole process. Those questions where among those that we did not get copies of. To this day I haven't gotten answers to those questions. Attorney Ottosen believes that the minutes are correct. Karl had presented what was sent to the Unions Attorney in Closed Session; came out of Closed Session and the Board was wanting to send a message that if the Union excepts what Karl sent to Lisa, the Board would ratify or approve it. Trustee Siegel was thinking the Board would have gotten a copy of the recommended changes, then the changes were going to be sent. Attorney Ottosen stated Action Item 19-07 in the minutes of the last meeting accurately states what happened. Karl apologized that the communications where not cleared up in Closed Session of things he had already done.

Attorney Karl Ottosen reported on the General Assembly. Every Spring for the last three years he has expressed concern on the property freezes on different bills in the House of the Senate. There seems to be more traction for some of them this year. A couple of them are a negative minus 5% from the previous year and 10% from the next year. As elective officials you need to be getting a hold of your State Representatives and Senators about the adverse effect this would be on the Fire District; The Lockport Twp. Fire Protection District is 90% reliant on property taxes for funding.

The Board would like a procedure put in the policy with instructions on an application process so that it can be put on the agenda for the Trustees to address at a Board Meeting. Trustee Siegel would like to look into insurance options for PSEBA Benefits. Trustee Siegel would like Robert Mondrella to pull out PSEBA Benefits from OPEB and put it under its own subcategory.
