Minutes of the Regular Meeting September 25, 2019

The Regular Meeting of the Lockport Township Fire Protection District was held on Wednesday, September 25, 2019, at Lockport Township Fire Protection District Station #6, 19623 Renwick Road, Lockport, Illinois.

Eric Anderson from Piper Jaffray discussed possible financing options for the new purchase of a new tower and engine and the possibility of refunding the 2013 Fire Notes. He explained the interest rates are at historic lows. Trustees requested Eric to prepare additional scenarios for the next meeting.

Motion by Trustee Paul Siegel, seconded by Trustee John Batusich to direct Eric Anderson to come back to the next meeting October 9, 2019 with alternative financing options for \$1.75/\$2.0 million in new money. Kevin Kalata from WJE appeared to discuss adding equipment to assist with the moisture mitigation at Station 3. After a lengthy discussion it was decided to wait to move forward with this proposal.
